## **LUGGAGE VALET** *and* **AIRLINE CHECK IN** **APPLICATION FORM**

Dear Guest:

Royal Caribbean International is proud to introduce a revolutionary new Luggage Valet and Onboard Check-In Service for international and domestic flights. This service provided by participating airlines will help expedite your departure from Fort Lauderdale Airport or Miami International Airport after your cruise vacation, as you will no longer need to check-in at the airport. For a service fee of \$20 per person, your airline check-in procedure will be processed here onboard and airline representatives will be on hand on the pier in Port Everglades to transport your luggage directly to the aircraft.

**Guests with International or Domestic flights with the airlines listed below are welcome to participate in this service. Delta Airlines is only available for domestic flights.**

Participating Airlines:

**Fort Lauderdale Airport:**

Alaska Airlines, American Airlines, United Airlines, Jet Blue, Southwest and Delta (Delta Airlines is only available for domestic flights). (Any connecting flight must be with the same airline)

**Miami International Airport:**

American Airlines, United Airlines and Delta (Delta Airlines is only available for domestic flights). (Any connecting flight must be with the same airline)

**Flights must depart after 11:30 am (from Fort Lauderdale) or after 2:00 pm (from Miami) on the day of the ship's arrival into Fort Lauderdale.**

If you meet all of the above requirements and are interested in participating in this service, please complete the registration information on the reverse of this form and return it to Guest Services, Deck 5, **no later than Wednesday noon.**

**Benefits of this service:**

- Your departure time will be at approximately 8:00 am, once your luggage has been cleared by Customs and Border Protection.
- Once you have departed the ship, you do not need to claim your luggage. You will simply go through the United States Customs & Border Protection checkpoint with your carry-on luggage. The next time you will see your luggage, it will be at your final airport destination.
- You will not need to check-in at the airport, since you have been already checked-in onboard.

# LUGGAGE VALET AND ONBOARD CHECK-IN SERVICE

**To participate in valet luggage program you need to meet all below requirements**

1. All flights from Fort Lauderdale must depart after 11:30 am on the day of the ship's arrival. (between 11:30 am to 11:59 pm)
2. All flights from Miami must depart after 2:00 pm on the day of the ship's arrival. (between 2:00 pm to 11:59 pm)
3. Service fee for Valet Service is \$20 per person. This amount does not include the baggage fees.
4. **Deadline to enroll is by Wednesday noon.**
5. Guests are responsible to add their full name (as shown in their passport), their flight details, destination, record locator and number of bags per guest. Once the form is completed please return it to Guest Services, Deck 5. Each guest wishing to participate in the Luggage Valet Program should have his/her name on the form.
6. **All guests participating in this program and flying Southwest Airline must have a flight between 11:30 am and 6:00 pm.**

**\*\*Note for Guests flying on Southwest Airline ( 24 hours prior to fly checked in Airline)**

7. Please be advised that the package for checked-in guests will be delivered with the evening service of your Stateroom Attendant on Friday (Day 9) between 6:00 pm and 9:00 pm.

**Please be advised that Royal Caribbean International is not an airline representative and is not responsible for check-in procedure seating assignment, upgrade, meals, wheelchair, etc.**
