# Dear Guest:

Royal Caribbean International is proud to introduce a revolutionary new Luggage Valet and Onboard Check-In Service for international and domestic flights. This service provided by participating airlines will help expedite your departure from Fort Lauderdale Airport or Miami International Airport after your cruise vacation, as you will no longer need to check-in at the airport. For a service fee of \$20 per person, your airline check-in procedure will be processed here onboard and airline representatives will be on hand on the pier in Port Everglades to transport your luggage directly to the aircraft.

Guests with International or Domestic flights with the airlines listed below are welcome to participate in this service. Delta Airlines is only available for domestic flights.

# Fort Lauderdale Airport:

Alaska Airlines, American Airlines, United Airlines, Jet Blue, Southwest and Delta (Delta Airlines is only available for domestic flights). (Any connecting flight must be with the same airline)

### Miami International Airport:

American Airlines, United Airlines and Delta (Delta Airlines is only available for domestic flights). (Any connecting flight must be with the same airline)

Flights must depart after 11:30 am (from Fort Lauderdale) or after 2:00 pm (from Miami) on the day of the ship's arrival into Fort Lauderdale.

If you meet all of the above requirements and are interested in participating in this service, please complete the registration information on the reverse of this form and return it to Guest Services, Deck 5, **no later than Wednesday noon.** 

# Benefits of this service:

- Your departure time will be at approximately 8:00 am, once your luggage has been cleared by Customs and Border Protection.
- Once you have departed the ship, you do not need to claim your luggage. You will simply go through the United States Customs & Border Protection checkpoint with your carry-on luggage. The next time you will see your luggage, it will be at your final airport destination.
- You will not need to check-in at the airport, since you have been already checked-in onboard.
